WHEREAS, the Entity is desirous that the Contractor executes the **BOLO CIS (REPAIR-CIS CY 2024)** located at **Labrador, Pangasinan** under Contract No. **R1-PIMO-24-01-034** (hereinafter called the "Works"), and the Entity has accepted the Bid for the said project in the amount of **NINE MILLION THREE HUNDRED SEVENTY-THREE THOUSAND ONE HUNDRED EIGHTY-SIX AND 97/100 PESOS ONLY (PHP 9,373,186.97)** by the Contractor for the execution and completion of such works and remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

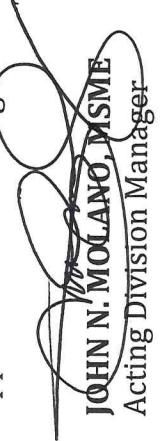

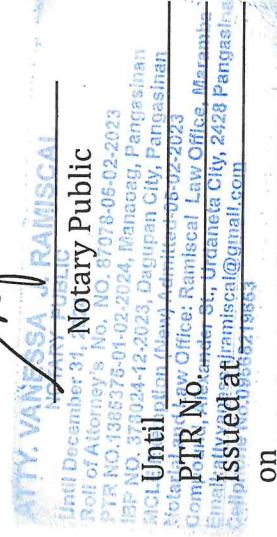
