**CONTRACT AGREEMENT** 

THIS AGREEMENT, made this \_\_\_\_\_ day of CT 3 1 2024 between the National Irrigation Administration - Pangasinan Irrigation Management Office, Urdaneta City, Pangasinan, represented herein by its Division Manager A, JOHN N. MOLANO, MSME (hereinafter called the "Entity"), and VYRAGUS CONSTRUCTION, 177 San Vicente East, Urdaneta City, Pangasinan represented herein by its General Manager, MUELVYN P. AGUSTIN (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the BAYAOAS SRIP CY 2024, PACKAGE 4 - EMBANKMENT PROTECTION (RIGHT MAIN CANAL), CONSTRUCTION OF IRRIGATION FACILITIES & OTHER APPURTENANT STRUCTURES located at Aguilar, Pangasinan under Contract No. R1-PIMO-24-09-093 (hereinafter called the "Works"), and the Entity has accepted the Bid for the said project in the amount of ELEVEN MILLION SEVEN HUNDRED SIXTY THOUSAND FIVE HUNDRED TWENTY-EIGHT AND 17/100 PESOS ONLY (PHP 11,760,528.17) by the Contractor for the execution and completion of such works and remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the




