

- b. Second (2nd) Installment, 7.5% of the Contract Price after the Contractor has fully mobilized the initial equipment and manpower required for the project as specified in this Bid Documents; and/or
- c. The advance payment of 15% of the Contract Price maybe claim if the Contractor is able to comply and submit all above-mentioned documentary requirements.

Unassembled materials delivered on the site shall not be included for payment.

The date by which "as built" drawings are required is prior to the submission of

the Final Billing Claims.

The amount to be withheld for failing to produce "as built" drawings by the date required is 1% of the total contract amount.
