

UNTALAN (hereinafter called the "Entity and Vyragus Construction with office address at 117 San Vicente East, Urdaneta City, Pangasinan represented herein by its Authorized Managing Officer, Mr. MUELVYN P. AGUSTIN (hereinafter called the "Contractor").

 - b. Performance Security;
 - c. Notice of Award of Contract and the Bidder's conforme thereto: and
 - d. Other contract documents that may be required by existing laws and/or the Procuring Entity. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of NINE HUNDRED NINETY-FOUR THOUSAND FOUR HUNDRED SIXTY PESOS & 20/100 (Php 994,460.20) or such other sums as may be ascertained. Vyragus Construction agrees to execute Laog-Vintar RIS; Construction/Repair of Water Master Quarters; CY 2022 in accordance with its Bid.
