THIS AGREEMENT, made this <u>17 APK 2023</u> between the National Irrigation Administration, Ilocos Norte Irrigation Management Office, Brow San Pablo, San Nicolas, Ilocos Norte, represented herein by its Acting Division Manager, Engr. WEYNARD JOSEPH P. UNTALAN (hereinafter called the "Entity and JPLC Trading with office address at 2F, 114 Ligaya st, 7<sup>th</sup> Ave., Caloocan City represented herein by its Proprietor, Mr. Angelito P. Carriedo (hereinafter called the "Contractor")

WHEREAS, the Entity is desirous that the Contractor executes Bolo RIS, Package 2; Modification of Intake; RRENIS; CY 2023, Dumalneg, Ilocos Norte under Contract No. INIMO-2023-01-003 (hereinafter called the "Works"), and the Entity has accepted the Bid for the said project in the amount of FOUR MILLION THREE HUNDRED SIXTEEN THOUSAND TWO HUNDRED FIFTY PESOS (Php 4,316,250.00) by the Contractor for the execution and completion of such works and remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this agreement, words and expressions shall have the same meanings as respectively assigned to them in the Conditions of the Contract hereinafter referred to.

- v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract</u> <u>execution, such as the Notice to Proceed, Variation Orders, and Warranty</u> <u>Security, shall likewise form part of the Contract</u>
