

THIS AGREEMENT, made on this _____ day of _____NOV 1 3 2023 _____ between NATIONAL IRRIGATION ADMINISTRATION, Regional Office No. 1, Brgy. Bayaoas, Urdaneta City, Pangasinan, represented herein by its Acting Regional Manager, Engr. Danilo V. Gomez (hereinafter called the "Entity") and GREEN-COLLAR CONSULTING SERVICES, Toog Avenue, P-4, Brgy. 2, San Francsico, Agusan del Sur, represented herein by its Chief Executive Officer, Mr. Raul L. Buñao (hereinafter called the "Consultant").

WHEREAS, the Entity is desirous that the Consultant execute Consulting Services for the Formulation of Management Plans for Irrigation Water Resources (MPIWR) of Tagudin NIS located at Suyo, Ilocos Sur under CONTRACT NO. R1-ISIMO-23-06-11 (hereinafter called "the Works"), and the Entity has accepted the Bid for the said project in the amount <u>TWO MILLION SIX HUNDRED SEVENTY-THREE THOUSAND TWO HUNDRED EIGHTY-EIGHT PESOS ONLY (Php2.673.288.00)</u> by the Consultant for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of <u>TWO MILLION SIX HUNDRED SEVENTY-THREE</u> <u>THOUSAND TWO HUNDRED EIGHTY-EIGHT PESOS ONLY (Php2,673,288.00)</u> or such other sums as may be ascertained, **GREEN-COLLAR CONSULTING SERVICES.** agrees to complete the works within **One Hundred Eighty (180) calendar days** in accordance with its Bid.

4. The NATIONAL IRRIGATION ADMINISTRATION agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
