Project Rationale	The proposed Ilocos Norte-Ilocos Sur-Abra Irrigation Project seeks to boost agricultural productivity, improve flood mitigation strategies, and offer additional incidental benefits. Specifically, the project's primary goal is to ensure a reliable allocation of additional water resources to address the irrigation water deficiency in Ilocos Norte and Ilocos Sur, during both the dry and wet season.
